 - Timeline for next steps with DOI
 - \$275/year- To cross reference. Provide a prefix for doi's. Have a doi for publications.
 - For each paper with a doi, would be an additional \$1/paper.
 - Copies an additional 15 cents
 - First year costs estimate = \$275 + all papers published in 9 volumes (65) = \$340
 - After that \$275 + cost of new papers (>\$20)
 - Can be accomplished in 1 year
